- ❖ Integra Synergy Medicaid Advantage Plus (MAP) (HMO SNP) is a plan for people who need Medicaid home care and long-term care services and covers Medicare services for those who live in the service area and have both Medicare Part A and Part B and have Medicaid.

This plan is designed to meet the needs of people who receive certain Medicaid benefits. (Medicaid is a joint Federal and state government program that helps with medical costs for certain people with limited incomes and resources.) To be eligible for our plan you must be eligible for Medicare and Full Medicaid Benefits and:

- Must be capable, at the time of enrollment of returning to or remaining in your home and community without jeopardy to health and safety, based upon criteria provided by New York State Department of Health; and  
Must be eligible for nursing home level of care (as of the time of enrollment)
- Must require care management and be expected to need at least one of the following Community Based Long Term Care services for more than 120 days from the effective date of enrollment:
  - a) nursing services in the home;
  - b) therapies in the home;
  - c) home health aide services;
  - d) personal care services in the home;
  - e) adult day health care;

<b>What is a Medicaid Advantage Plus (MAP/ HMO + D-SNP) plan?</b>	<p>Our MAP plan is a Health Maintenance Organization (HMO) aligned with a Dual Special Needs Plan (D-SNP). Our plan combines your Medicaid home care and long-term care services and your Medicare services. It combines your doctors, hospital, pharmacies, home care, nursing home care, and other health care providers into one coordinated health care system. It also has care coordinators to help you manage all of your providers and services. They all work together to provide the care you need.</p> <p>Our MAP plan is called Integra Synergy Medicaid Advantage Plus (MAP) (HMO SNP).</p>
<b>Will you get the same Medicare and Medicaid benefits in Integra Synergy Medicaid Advantage Plus (MAP) (HMO SNP) that you get now?</b>	<p>If you are coming to Integra Synergy Medicaid Advantage Plus (MAP) (HMO SNP) from Original Medicare or another Medicare plan, you may get benefits or services differently. You will get all your covered Medicare and most of your Medicaid benefits directly from Integra Synergy Medicaid Advantage Plus (MAP) (HMO SNP). You will work with a team of providers who will help determine what services will best meet your needs. When you enroll in Integra Synergy Medicaid Advantage Plus (MAP) (HMO SNP), you and your care team will work together to develop a Care Plan to address your health and support needs.</p> <p>When you join our plan, if you are taking any Medicare Part D prescription drugs that Integra Synergy Medicaid Advantage Plus (MAP) (HMO SNP) does not normally cover, you can get a temporary supply. We will help you get another drug or get an exception for Integra Synergy Medicaid Advantage Plus (MAP) (HMO SNP) to cover your drug, if medically necessary. <p><b>What are long-term services and supports?</b></p>	<p>Long-term services and supports are services that help people who need assistance doing everyday tasks like taking a bath, getting dressed, making food, and taking medicine. Most of these services help you stay in your home so you don't need to move to a nursing home or hospital.</p>
<p><b>Where is Integra Synergy Medicaid Advantage Plus (MAP) (HMO SNP) available?</b></p>	<p>The service area for this plan includes the following counties in New York: Bronx, Kings, Nassau, New York and Queens. You must live in one of these counties to join the plan. Call Customer Service for more information about whether the plan is available where you live.</p>
<p><b>What is prior authorization?</b></p>	<p>Prior authorization means that you must get approval from Integra Synergy Medicaid Advantage Plus (MAP) (HMO SNP) <b>before</b> you can get a specific service or drug or see an out-of-network provider. Integra Synergy Medicaid Advantage Plus (MAP) (HMO SNP) may not cover the service or drug if you don't get approval. <b>If you need urgent or emergency care or out-of-area dialysis services, you don't need to get approval first.</b></p> <p>See Chapter 3, of the <i>Evidence or Coverage</i> to learn more about prior authorization. See the Benefits Chart in Chapter 4 of the <i>Evidence or Coverage</i> to learn which services require a prior authorization.</p>
<p><b>What is a referral?</b></p>	<p>A referral means getting access for certain plan benefits from your primary care provider (PCP) <b>before</b> you can see providers in the plan's network. If you don't get approval, Integra Synergy Medicaid Advantage Plus (MAP) (HMO SNP) may not cover the services. You don't need a referral for certain benefits. <b>What is the maximum out-of-pocket amount that you will pay for medical services as a member of Integra Synergy Medicaid Advantage Plus (MAP) (HMO SNP)?</b>	There is no cost-sharing for <b>medical services</b> in Integra Synergy Medicaid Advantage Plus (MAP) (HMO SNP), so your annual out-of-pocket costs will be \$0.
